Message from our President, Mary Giventer:

At this time of year we remember our nation's history with the President's Day Holiday and Black History Month in February and Women's History Month in March. This month, 93 years ago, Carrie Chapman Catt founded the League of Women Voters. Since that time, the League has worked to extend voting rights and to ensure that our elections are fair, free and accessible to all eligible voters. That work is still not done. Within the next few weeks the Supreme Court will hear oral arguments, and eventually rule, on the constitutionality of the historic Voting Rights Act of 1965. Some of us are old enough to remember the marches and registration attempts by brave civil right workers, often met by violence and bloodshed that led up to the passage of the Voting Rights Act, ensuring the right to vote regardless of race. While it is very discouraging to realize that basic right is being challenged once again, it is heartening that the League is once again standing up for voting rights. League members are literally standing up on the Supreme Court steps making their voices heard, and the League has filed an amicus brief with the court in support of the Voting Rights Act.

Locally, we can be proud that our local founder, Helen Pierce, has been named Stanislaus County Woman of History for 2013 by the Stanislaus County Commission for Women. In 1947 Modesto was facing significant problems related to rapid post war population growth - inadequate sewage system, an insufficient number of schools, traffic and parking problems, and city regulations and ordinances that did not fit with the city's new growth. Helen, a librarian at Modesto Junior College and an active leader in the American Association of University Women, decided that Modesto needed a local League of Women Voters to inform its citizens and encourage active citizen participation in shaping Modesto's future. Sixty-six years later we are still fulfilling that role.

Carrie Chapman Catt's words are as true today as they were 93 years ago: *Everybody counts in applying democracy. There will never be a true democracy until every responsible and law-abiding adult in it, without regard to race, sex, color or creed has his or her own inalienable and unpurchasable voice in government.*

National Action:

When the Voting Rights Act was last reauthorized in 2006 with overwhelming bipartisan support, Congress declared that without its protections, “racial and language minority citizens will be deprived of the opportunity to exercise their right to vote.” However, the constitutionality of this Act is being contested in the Supreme Court. The Court will focus on Section 5, which applies to specific states or jurisdictions with histories of discriminatory voting practices and requires that these jurisdictions obtain “preclearance” for proposed changes in their election laws. The LWVUS has signed on to an amicus brief in support of Section 5 and will be participating in a rally at the Supreme Court on February 27. On February 17, the LWVUS joined participants in the “Climate Rally” in Washington DC and other cities throughout the nation. Rally participants called on President Obama to reject the Keystone XL tar sands pipeline and to limit carbon pollution from power plants.

State Action:

CEQA, The California Environmental Quality Act, a state policy of environmental protection was established in 1970, shortly after Congress passed the National Environmental Policy Act. However, some state legislators and others have proposed weakening the law’s key tenets by limiting public input into land use planning and weakening environmental and public health protection. LWVC has joined CEQA Works, a coalition of civic, conservation, environmental justice, labor, preservation and public health groups to protect CEQA. Participating organizations are committed to educating California’s residents and legislators about the significant benefits this law has brought to the state since it was enacted by Governor Ronald Reagan 43 years ago. Lunch and Learn:

Jean Okuye, Merced County Farm Bureau President, is our Lunch and Learn speaker for February. Local Action:

More than 30 members and guests heard Modesto Mayor Garrad Marsh discuss Salida and public safety. Hearing that LWVC is currently studying the Initiative and Referendum Process, he prefaced his remarks with a caution that he feels the current system is being abused, often at the expense of local governments, and is in need of review.

On the Salida annexation/incorporation issue, Mayor Marsh noted that people generally do not like change and do not trust government. However, he said change will come to Salida, the largest unincorporated area in the county, as a result of Salida Now, a 25-year development agreement that commits five square miles of farmland to home construction, fees from which would fund infrastructure for business parks. The plan was approved by the Stanislaus Board of Supervisors in 2007 without a vote of the people. The recent economic/housing downturn has made this plan less viable today. Salida is back on the front burner starting with a city/county study to determine the area's economic future. Salida has three options: status quo, incorporation or annexation to Modesto. Mayor Marsh favors the last option, while recognizing that ultimately the decision is for residents of Salida to make. He hopes that information from the study and other discussions will make Salidans more open to his proposals, a process that will take time.

On public safety, Mayor Marsh presented figures on crime increase – up 20 to 25 percent in California with the national increase at 4 to 5 percent. Realignment – the release of non-violent criminals from state prisons to the counties - is contributing to that increase. He has organized a community forum to generate ideas for local efforts to reduce crime. Although some efficiencies may be possible, the bottom line is that more money is needed to provide more services such as increasing police responses to calls, anti-gang efforts and gang prevention activities.
