***Gang Violence: Not a Pretty Picture  
Lunch and Learn, February 2014***

At February's Lunch and Learn, Assistant District Attorney/Gang Unit Prosecutor Tom Brennan painted a vivid and bleak picture of gang violence in our area. With videos, photos and stories behind recent gang-related trials, Mr. Brennan introduced us to the criminals, especially young offenders, and their victims. Although he makes efforts to prevent youthful offenders from committing violent crimes, once they "cross over," he takes a hard line to prosecute them. These include 14 – 16 year old murderers who have been tried as adults. He takes pride in the work he does to remove violent offenders from our streets. Mr. Brennan described the influence of prison-based gangs on local criminal activity, the Norteno/Sureno conflicts, kids willing to "do what it takes to be a gang member" and the gang history in some families. The scenarios suggest that some kids don't have a chance.

Mr. Brennan said prevention and intervention strategies, unfortunately, usually don't work – unless a young, low-level offender will commit to bettering himself. Because of peer pressure, the allure of gang life is often more attractive to young people than are opportunities offered by numerous intervention strategies including school. With 10,000 Norteno gang members in Stanislaus County, the gang message is everywhere - delivered through self-made CDs and videos and, of course, graffiti. Gang graffiti often leads to more violence when it is sprayed over by a rival gang, an act of disrespect.

**January Lunch and Learn with Clerk-Recorder Lee Lundrigan**

Lee Lundrigan has been Stanislaus County's Clerk-Recorder for 12 years and is running for reelection in the June gubernatorial primary along with other county elected officials. She feels that the responsibility of elected officials is to serve. Recognizing that candidates' qualifications vary, she praised League for its role in elections, especially providing opportunities for voters to listen to and question candidates.

Ms. Lundrigan talked about the three distinct functions of her department. The Clerk responsibilities include Commissioner of Civil Marriage and elections, the latter taking 80% of her time. The increase of electronics in the election process presents challenges; her goals are to guarantee voters anonymous paper ballots regardless of electronic innovations and to protect voters' personal privacy. Currently in Stanislaus County, mail-in ballots are 70% of votes cast which requires specific procedures to validate signatures. The job of the Recorder is essentially to make information public. Once transactions are complete and recorded, they are public – a practice unique to America.

She also gave some historical explanations for current practices. Tuesday elections date back to 1845 when voters had to go to the county seat – a one-day horse ride away – and to avoid conflict with religious services; November is after harvest and before winter! Local elections are on a different schedule so as not to be buried by federal or state electoral hype or a tendency to pattern or party voting.

In response to questions about polling places, she explained the complexity of preparing multi- district ballots and the changing jurisdictions after each census. She cautioned against registering to vote with paid registrants who may want to "help" complete the form and the potential of handing over ID information to a "stranger". Take the form and mail it in! She opposes Instant Runoff because it requires a computer, not paper ballot, and the first place candidate may not win. All mail-in elections are considered by the Supervisors, but she feels it should ultimately be decided by voters. In conclusion, she encouraged families who receive duplicate sample ballots to "Go Green" by receiving all but one on-line – saving \$1 to \$2 each! ## LEGISLATIVE INTERVIEW WITH SENATOR CANNELLA

Several members of the Merced and Stanislaus County Leagues jointly interviewed State Senator Anthony Cannella in his 12<sup>th</sup> District Modesto office on February 28, 2014. Mary Giventer, Ellen Dunbar and Hanna Renning represented the Stanislaus League. A full report was submitted to the California League on March 3. What follows are highlights of the questions and answers from the interview.

League of Women Voters California (LWVC), (MONEY IN POLITICS): “Will you help see that effective measures are passed in the Assembly/Senate to require disclosure of the sources of all contributions in California campaigns and to make campaign disclosure more transparent and user-friendly in general?”

Senator Cannella (SC): Yes. Senator Cannella supported SB 52 (Mark Leno) in 2013. He plans to support SB 27 (Correa) this session. (PLEASE NOTE: After the interview, on March 10, 2014, Senator Cannella’s Chief of Staff, Dillon Gibbons, spoke to Hanna Renning, a member of the interview panel, to explain that Senator Cannella’s support for SB27 was now uncertain. The senator still supports the legislation as originally written, but not in its amended form, after the State Assembly voted to make it an “urgency bill.” Senator Cannella thinks that those affected should have more time to make adjustments.)

LWVC : (EDUCATION) “The LCFF (Local Control Funding Formula) is rolling out over the next few years. Implementation strategies are being drafted and there will inevitably be some adjustments. What do you see as the ongoing role of the legislature? Are there programs you feel should remain categorical? Are there areas you deem as off limits for spending supplemental and concentration funds?”

SC: Senator Cannella is a big proponent of the LCFF. In his opinion it is needed to eventually equalize the discrepancies between “rich” and “poor” schools districts and give all students access to a good education. He considers it the most advanced reform in this area since Proposition 98. While the LCFF is a state formula to fund school budgets, it will give control of how to spend the grants to local school boards, with the input and support of a community committee. The great challenge will be how to involve the parents of English learners.

Senator Cannella does see the need for some categoricals, such as special education and (perhaps) transportation. He also indicated that he would advocate for some agricultural program funding.

LWVC: California Environmental Quality Act (CEQA, LWVC Question) “Do you think specific projects should be exempted from parts or all of the California Environmental Quality Act (CEQA) process, or have special rules set for them? If so, how would you determine which projects should receive such treatment?”

SC: Senator Cannella likes the CEQA process and thinks that no aspect should be exempted. However, legislation should be formulated to prevent lawsuits from being filed at every step of the CEQA review of a project so that things could move along better. Lawsuits should address issues, not be used as delaying devices. There should be some flexibility, with special rules for some large-scale public projects (so long as these do not favor the big guys). An example is the CEQA/Salinas River Cannella-sponsored bill SB 1398 which would streamline the CEQA process to allow Salinas River cleanup for flood protection.

LWCV: (GROUNDWATER, Local League Question) “What is the role of the state in setting policy for managing groundwater? What are the roles of counties and irrigation districts?”

SC: “We have to change, before groundwater is depleted”. National and state policies do not address recharging of aquifers. Senator Cannella favors a statewide water policy, which he says has not really existed for fifty years. He would like a better definition of the state’s role in enforcing this policy.

Cannella-sponsored bill SB927 (Water Bond), which focuses on storage, delta conveyance, and safe drinking water for disadvantaged communities, is presently moving through the legislative process. It is slated for the November 2014 ballot.

Final comment: We must deal with the water issue now. We feed the world, and world peace depends on food being available to all.

LWVC (MAJOR ISSUES AND PRIORITIES) “What other major issues do you think the legislature must deal with in 2014? What are your personal priorities?”

SC: UC Merced Medical School should be in place as soon as possible to prevent a shortage of physicians needed to treat the increased numbers of patients resulting from the Affordable Care Act.

-Transparency: All public agencies should operate under Tax ID numbers for accountability in spending. This would prevent situations like that of the Parks Service from developing.

-SB 920 (200 Year Flood Protection) is jointly authored with Senator Galgiani. This bill will allow counties to make a finding of “adequate progress” if the agency is in the planning stages of meeting 200 year flood protection.
