We are not far into 2014 and it has already been a busy year for our League. We have expressed our view on the land use portion of the amendment to Modesto's General Plan, advocating for the preservation of the prime farmland west of Highway 99. Although the Modesto City Council adopted a compromise plan that does not fully address our concerns, the proposed plan will now undergo an Environmental Impact Review (EIR). We will continue to monitor this issue in the coming months.

Thank you to Michael Fuller, Marie Bairey, Ellen Dunbar, Carmen Morad and Ruby Hennessey for assisting with the Associated Student election at CSU Stanislaus. On February 19th we set up a voter registration table at the Student Activity Awareness Day, also at CSU Stanislaus. Plans are underway for the Legislative Interview with State Sen. Anthony Cannella, which we will be undertaking with the Merced League. Thank you to Ellen Dunbar and Hanna Renning for working on this.

Thank you to Seena Rhine for hosting and leading our program planning meeting, and thank you to everyone who attended and provided their thoughtful input. It always impresses me how well thought out and how well worded our positions are.

Adopt-a-Poll

When County Clerk/Recorder Lee Lundrigan spoke to League members at the January Lunch and Learn, she told us about the Adopt-a-Poll program. Here's how it works. Rather than individuals working at an election polling place, a group can "adopt" that poll and provide workers for the day. Volunteer poll workers would have to complete the training, and a bilingual Spanish-speaker is required for each poll. Poll workers could work in shifts, instead of the usual 14 hour day, so long as the requisite number of poll workers is there. In exchange, the stipend paid to individual poll workers (usually about \$500 per poll) is then paid to the adopting group.

What an opportunity for League, for visibility and to be an integral part of the democratic process! If League were to adopt a poll, 8-12 volunteers would be needed on Election Day, depending on the length of the shifts. Is there interest among League members to put together a team to adopt a poll?????

State Action: PROTECTING THE RIGHT TO VOTE

State—The League of Women Voters of California has joined in a lawsuit filed on February 4, 2014, by the ACLU of California and the Lawyers' Committee for Civil Rights of the San Francisco Bay Area in Alameda County Superior Court on behalf of three persons being deprived of their right to vote by an action of the California Secretary of State.

After passage of the Criminal Justice Realignment Act, the Secretary of State in December 2011 sent a directive to local elections officials saying that all persons on post-release community supervision or mandatory supervision should be barred from voting. Even those convicted of low-level, non-violent, non-serious crimes would be included. This directive applies to approximately 60,000 persons otherwise eligible to vote. People of color are disproportionately affected.

The lawsuit, also supported by the prisoner rights organization All of Us or None, contends that under provisions of Proposition 10, passed by California voters in 1974, only those in state prison or on parole are ineligible to vote. "Voting should be part of a successful reintegration into one's community, but the Secretary of State's memo takes us in the wrong direction," said Jennifer Waggoner, President of the League of Women Voters of California. "People of color are being disenfranchised and thousands of voters and county officials are being confused about their voting rights. The strength of our democracy comes from allowing everyone to fulfill their civic responsibility to vote."

Free Workshop with Kim Klein Tuesday, March 18, 10 AM CSU Stanislaus Event Center

We all know the difficulties facing non-profit groups across the board. Raising money is becoming more difficult, volunteers are being stretched to the limit, and at the same time both the cost of business and the need for services is increasing. At all levels, from school boards and city councils to state legislatures and Congress, governmental decisions on the allocation of funds impacts the ability of non-profits to achieve their goals. Is there a way we can have a real say in their decisions? Is there a way we can all do better?

Kim Klein believes there is! She has wide experience in all aspects of fundraising and is currently working with the Building Movement Project to develop collaborative efforts among non-profit groups. Whether you work for a homeless shelter or an arts group, with at risk children or the elderly, Kim believes that a concerted effort across a broad spectrum of non-profit groups is needed to provide a voice for the common good. In this workshop she will address the California budget process and tax structure and give us the information and tools we need to develop our collective strength. She believes we all do better when we all do better.

This is a two-part workshop. In the morning from 10 AM to 12 noon Kim will present information needed by those in the non-profit sector to understand and address basic public budget issues. Anyone interested is invited to attend. In the afternoon, from 1 PM to 3 PM she will work on a more personal, in depth level with those most active in their organizations.
